**APPLICATION FOR TRANSFER OF REGISTRATION OF STANDARDBRED  
HORSES WITH SPPHA NSW**

Registration provides official identification of the horse, which may be requested for equestrian competitions and/or breed classes by event/show committees. It also officially identifies a person as the owner of the horse.

Please note the following in regards to transfer of registration with SPPHA NSW:

- This is a legally binding document and under no circumstances will the SPPHA of NSW Inc enter into any ownership dispute arising from this transfer
- The **correct fee** and **original** Certificate of Registration must accompany this application
- Applications for transfer of registration will only be accepted from current financial members of SPPHA NSW (see attached forms for Membership Fees)
- Definitions of registration, eligibility for competition and requirements for association membership may differ with other Standardbred associations. Please check with these organisations to confirm their requirements if competing outside NSW
- For horses under the SPPHA NSW adoption/placement program, transfer of registration will automatically occur at the end of the lease period as part of the adoption process
- If the name and signature of the seller cannot be obtained (e.g. the horse was given away some time ago) the buyer [transferee] must complete a **Statutory Declaration** giving dates and explaining the circumstances under which they came into possession of the horse

To complete the registration process:

- The buyer is to register as a member or nominate (if they are not already a current financial member)
- Complete the horse information on the transfer of registration forms (1 copy for buyer [transferee]; 1 copy for seller [transferor]; 1 copy for SPPHA NSW Inc). NB: all signatures must be handwritten originals.
- Enclose the **original** Certificate of Registration + the SPPHA copy of the transfer of registration forms for owner details to be updated + Statutory Declaration (if applicable)
